1.0 HEALTH, SAFETY AND ENVIRONMENTAL POLICY

The Health, Safety and Environmental (HSE) Program is to be used throughout Cashman Equipment Corporation (CEC) and affiliated companies; {including but not limited to: Cashman Scrap and Salvage (CSS), LLC; Servicio Marina Superior (SMS), LLC; CHM Maritime, S.A. de C.V.} operated facilities, jobsites, barges and/or vessels.

Cashman Equipment Corporation is firmly committed to ensuring that our employees, customers and contactors have a workplace free of recognizable hazards and that our equipment and operations do not, in any way, cause or further enhance existing damage to the environment. Health and Safety of our people and protection for the Environment has received our Highest Priority. It is Company Policy that all activities are conducted as a priority governed by the Health and Safety of our employees including all other personnel that we work with. We are committed in promoting the awareness, protecting and conserving the environment.

Health, Safety and Environmental Management objectives of Cashman Equipment Corporation are:

- Ensuring adherence at all times to the documented operating procedures by a system of internal and/or external verification of procedures and activities;
- Continuously reviewing all mandatory rules, regulations and industry codes and guidelines that are relevant to specific vessel types and trades.
